

ANÁLISE MENSAL

As chuvas no mês de fevereiro foram bem concentradas no início do mês, até o dia 12, com um pouco de chuva entre os dias 22 e 24. Nos dias iniciais ocorreram registros de chuvas bem intensas, com registros diários maiores que 100mm/dia, registrada em 4 estações. Ocorreu uma grande variação espacial da chuva no mês, com variação entre 14,8 mm, na estação **CORREGO SAIA VELHA**, a 231,8 mm na estação **CEILÂNDIA**. Os dias 02 e 11 foram os mais chuvosos, com várias estações registrando acumulados diários superiores a 50mm/dia.

A Precipitação foi maior em uma região que se estendeu do Centro/Norte em direção ao Oeste, do Distrito Federal, com a chuva menores na porção Leste e Sul. A média mensal da Precipitação, de todas as estações utilizadas, foi de 105,7mm, 73% da média climatológica do INMET (1991-2020) de 226mm. Das 69 estações utilizadas, em todo o DF, apenas 18 ficaram acima da média climatológica do INMET, para o acumulado mensal.
